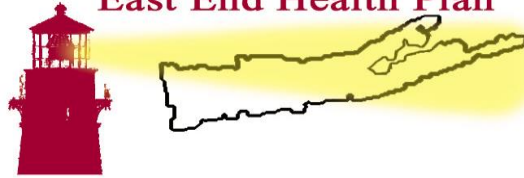

Dear East End Health Plan Member:

As you are aware, all our Medicare Primary members will be enrolled in the East End Health Plan Medicare Advantage Plan effective January 1, 2020.

As indicated in our previous notices regarding this transition, I would like to emphasize that our Medicare Advantage Plan has been customized so it provides the same coverage that our members currently receive. We do this by combining the Medicare primary portion of coverage, our EEHP secondary coverage and our Prescription Drug coverage all under one Primary Coverage Plan. This Primary Coverage Plan will be administered by Empire BlueCross/BlueShield under their MediBlue PPO plan. It provides the same benefit coverage as you currently receive.

The critical points that our Medicare Primary members need to be aware of are:

1. You can still see your current providers.
2. You don't have to be concerned with in-network or out-of-network providers. As long as your Providers participate in Medicare and submit the claim directly to BlueCross/BlueShield, they are covered.
3. There will be zero co-pay for medical services.
4. There will be zero out-of-pocket costs.
5. The Prescription Drug co-pay structure will not change. The majority of our members will see no change or a reduction in their Prescription Drug co-pays.
6. You will continue to be reimbursed by your School District for your Medicare Part B premiums.


